

SpringFest Ticket Purchase Policy and Rules Agreement

Welcome to SpringFest! We are excited to have you join us for this fantastic event. Before you purchase your tickets, please carefully read and understand the following policy and rules. Your purchase of a ticket constitutes acceptance of these terms.

1. Ticket Purchase and Refund Policy:

All ticket sales are final, and no refunds will be issued, except in the case of event cancellation due to severe weather conditions. In such cases, a partial refund may be considered. You are allowed to move your tickets to another day one week before the event date. Contact us for help.

Any purchase or possession of tickets for the Event constitutes the irrevocable acceptance of, and the agreement to be bound by, all of the terms and conditions contained herein. If you do not agree to be bound by these terms and conditions, do not purchase Tickets.

2. Weather Conditions:

SpringFest is an outdoor event, and as such, attendees acknowledge and accept the inherent risks associated with variable weather conditions. The event will proceed rain or shine unless conditions pose a threat to the safety of attendees, performers, or staff.

3. Risk Acknowledgment:

Attendees voluntarily assume all risks and dangers incidental to the event for which the ticket is issued, whether occurring before, during, or after the event.

I hereby expressly waive and release any and all claims which I have or may in the future have against the Company, its affiliates, and their respective directors, officers, employees, agents, representatives, shareholders, successors and assigns (collectively, "Releasees"), on account of injury, death or property damage arising out of or attributable to my participation in the Activities, due to any cause whatsoever, including without limitation the negligence of the Company or any other Releasee, breach of contract, or breach of any statutory or other duty of care owing under occupiers liability legislation or otherwise. I covenant not to make or bring any such claim against the Company or any other Releasee, and forever release and discharge the Company and all other Releasees from liability under such claims.

4. Photography and Recording:

Attendees are permitted to take photographs and videos for personal, non-commercial use. By attending SpringFest, you grant permission to the event organizers to use your image in promotional materials, social media, and other publicity efforts.

5. Publicity Consent:

Attendees consent to the use of their name, likeness, image, and/or voice in any broadcast, photograph, video, or other account of the event for promotional and marketing purposes.

I hereby irrevocably permit, authorize, grant, and license Company and its affiliates, successors and assigns, and the employees, officers, directors, and agents of each and all of them ("Authorized Persons"), the rights to display, exhibit, transmit, broadcast, reproduce, record, photograph, digitize, modify, alter, edit, adapt, create derivative works, otherwise use, and permit others to use, my first name, image, likeness/appearance, voice, and all materials created by or on behalf of Company that incorporate any of the foregoing ("Materials") in perpetuity throughout the universe in any medium or format whatsoever now existing or hereafter created, including but not limited to, in and on magazines, brochures and other print publications, electronic, magnetic and optical media, motion pictures, television broadcast, cablecast and satellite, radio broadcasts, display, point-of-sale, and other advertising and promotional materials, press releases, the internet and other digital transmission or delivery methods, mobile applications, on any platform and for any purpose, including but not limited to advertising, public relations, publicity, packaging, and promotion of Company and its affiliates and their businesses, products, and services, without further consent from or royalty, payment, or other compensation to me except as otherwise expressly provided in this Agreement. In the event that COVID-19 restrictions are lifted or reinstated, we reserve the right to move from a drive through event to a walk-through event (or vice versa). Drive through tickets will be honoured in accordance with the number of people per vehicle. Company shall be the exclusive owner of all right, title, and interest in and to the Materials, including all copyrights. I hereby irrevocably transfer, assign and otherwise convey to Company my entire right, title and interest, if any, in and to the Materials and all copyrights and other intellectual property rights in the Materials arising in any jurisdiction throughout the universe in perpetuity, including all registration, renewal and reversion rights, and the right to sue to enforce such copyrights against infringers. I acknowledge and agree that I have no right to review or approve Materials before they are used by Company.

6. Code of Conduct:

Attendees must adhere to a code of conduct that promotes a safe, respectful, and enjoyable environment for all. Any disruptive or inappropriate behavior may result in removal from the event without refund.

7. Security Measures:

SpringFest reserves the right to implement security measures to ensure the safety of all attendees. Cooperation with security personnel is mandatory.

8. Event Changes:

SpringFest organizers reserve the right to make changes to the event schedule, lineup, or other aspects without prior notice. In such cases, no refunds will be issued.

9. Lost or Stolen Items:

SpringFest is not responsible for lost or stolen items. Attendees are encouraged to secure their belongings and report any incidents to event staff.

10. Health and Safety:

Attendees must comply with any health and safety protocols in place, including but not limited to COVID-19 guidelines, if applicable.

11. Representations and Warranties of the Ticket-Holder

I represent and warrant to Company that I am at least eighteen (18) years of age and I have full right, power and authority to enter into this Agreement for myself and/or on behalf of my child who is a minor ticket-holder. I further represent and warrant to Company that I will provide only true and correct statements and other information in connection with this Agreement.

12. Acknowledgement

By purchasing a ticket to SpringFest, you acknowledge that you have read, understood, and agreed to abide by these policies and rules. Failure to comply with these terms may result in your removal from the event without refund. SpringFest organizers reserve the right to modify these terms at any time without prior notice.

THE FOLLOWING TERMS AND CONDITIONS APPLY TO ALL TICKET PURCHASES MADE FOR SPRINGFEST (the "EVENT/Event"). ANYONE PURCHASING A TICKET IS CONSIDERED TO HAVE AGREED TO THIS AGREEMENT IN ORDER TO ENTER THE EVENT. ENTRY INTO THE BOUNDARIES OF THE EVENT SHALL BE CONSIDERED ACCEPTANCE.
